- a. The Town of Vici has a REAP question. They want to apply for a tractor that would help with streets and mowing as well as resurface streets. Would these be two separate applications or can they apply under one application for both? The board discussed that they consider that two separate applications.
- b. Kirk Fisher, Mayor of the Town of Beaver, shared his concern around his CDBG and REAP project to resurface streets in town. He felt penalized for having two grants because it might not allow him to apply for the next REAP cycle if they cannot close the REAP and CDBG grants by the FY20 REAP application deadline. The board listened to his concerns and are taking it under advisement.
