  - A. Staff reporting:

- a. Beaver County RWD1 #BV20-1 second contract request. Due to severe winter weather and COVID-19 situation, material shipments are delayed. Please extend the contract to Sept 15, 2021. Although it did not need board member approval, Firgard asked for the Board's blessing to extend the date and all the board members felt that it was okay to do so.
- b. Woods Co RWD3 #WD21-4 Asking to change the project from painting interior / exterior of two towers to painting the outsides only on all 4 water towers. Then Woods Co RWD3 would work on interiors on the next REAP grants. There is not enough funding to get interiors done at this time. Strain made a motion to approve the changes, to add the other two towers to his grant plan to do just the outside of all 4 towers at this time, with a second from Rose.
